FRANCIS

What Is FRANCIS and Why Should I Use It?

The *FRANCIS* database is created by the Institut de l'Information Scientifique et Technique (INIST-CNRS) of the Centre National de la Recherche Scientifique in Vandoeuvre-les-Nancy (France). Its breadth of subject areas and international scope complement many more narrowly focused databases, making *FRANCIS* an invaluable resource for scholarly research.

The *FRANCIS* database covers wide range multilingual, multidisciplinary information in the humanities (62%) and social sciences (38%). *FRANCIS* is particularly strong in the following subject areas: religion, psychology, sociology, literature and linguistics.

FRANCIS contains records for a variety of materials, including serials, journal articles, books, book chapters, conference papers, see Publication Type part...

Subject descriptors on records in the *FRANCIS* database are listed in both English and French. Approximately 74% of abstracts are in French and 26% in English. The *FRANCIS* database covers 1984 to the present, and is updated monthly.

Short story of *FRANCIS* and Indexing

FRANCIS is the computerized version of “Bulletins Signalétiques thématiques” from CNRS, published (print version) from 1947 to 1994. Each descriptive bulletin was a set of themes with their own editorial board.

In 1972, they created FRANCIS to give a computerized access to this « bulletins signalétiques » and propose multidisciplinary possibilities of interrogation.

Selection Policy

Francis offers a list of indexed journals on their website. These journals have gone through a vetting process before being accepted and the issues are indexed in the order in which they are received. An article in an indexed journal may be not cited if the given article is not deemed by the editor to deal with Francis topics. Books in all areas of Francis are accepted for indexing after examination.

Each reference in FRANCIS is analyzed by an indexing specialist. The analysis includes an Abstract (80% of references with Abstract, 74% Abstracts are in French), one or some code of classification and a bilingual indexing (French-English).

The indexing is done starting from a controlled vocabulary specific to each discipline. Amérique Latine and Histoire des sciences et des techniques have a controlled indexing in 3 languages : French-English-Spanish and the base Informatique et sciences juridiques in French-English-German. Index terms not belonging to the controlled vocabulary can also be added in order to bring complementary elements specific to the analyzed article.

The controlled vocabularies and classification scheme were carried out by the engineers specialized in the discipline concerned as of the creation of the base. They are alimented each year after analysis of the non-controlled terms introduced into the indexing in order to follow the evolution of the disciplines as well as possible.

Publication Types

FRANCIS indexes 5 publication types that are searchable on CSA Illumina by using the Publication Type field code (PT=). These document types include journal article, book, conference meeting, report and thesis. These publication types are searchable by their name using the field code for each type.

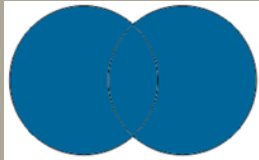

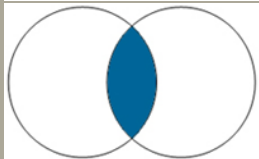

Boolean Operators and Other Search Tools:

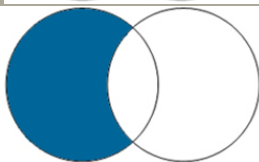
Boolean operators help define the relationships between words or groups of words.



Use **OR** to broaden a search and retrieve records containing any of the words it separates, e.g. **art or allegorie** will find records containing art only, allegorie only, or both words.



Use **AND** to narrow a search and retrieve records containing all of the words it separates, e.g. **art and allegorie** will only find records containing both these words.



Use **NOT** to narrow a search and retrieve records that do not contain the term following it, e.g. **art not allegorie** will find records that contain art, but will not contain the word allegorie.

()

Use parenthesis to group words or search expressions when applying Boolean logic, also use to show the order in which search expressions are to be executed

Ie : France and (art or allegorie)

CSA Illumina requires three characters at the beginning of a word before truncation or wildcard characters may be used.

Search queries containing several operators are executed in the following order:

(), NEAR, NOT, AND, OR

Proximity operators identify the number of words to come between the search terms.

WITHIN X

Use to narrow a search by specifying a proximity relationship of fewer than "X" words between search terms, e.g. **art within 3 allegorie**

NEAR

Use to narrow a search by specifying a proximity relationship of fewer than 10 words between search terms, e.g. **art near allegorie**

Special symbols *can expand the scope of your search*

- * Truncate using an asterisk. This expands a search term to include forms of a root word, e.g. *allegor** retrieves *allegory, allegoric, allegorical, allegorically; etc.*
- * Find an unlimited number of characters within a word, e.g. *col*r* retrieves *colour and color*
*behavi*r* would be used to retrieve **behavior** and **behaviour**
- ? Find alternative spellings. The ? represents any single character; ?? represents two characters and so on. Use within or at the end of a word, e.g. *customi?e* finds *customize* as well as *customise*, *fib??* will find *fiber* and *fibre*

On CSA Illumina, search strategies can be applied using one of three approaches.

Quick Search

By default the quick search screen searches the anywhere field (AY=). An anywhere search searches across all of the available fields in a record. Multiple words entered into the search field, will be treated as a phrase.

When viewing records on CSA Illumina both the author and descriptors are hot linked. Clicking on the hot-link will search the database for each occurrence of the selected author or descriptor.

If your administrator has activated the *Discovery links*, you will see extra information: the Discovery links allow users to link out and discover alternative content related to their research. Discovery links include user activated searches into image databases, Wikipedia, and publication information databases such as Ulrich's Periodicals Directory. Depending on the resource, discovery links may be matched with the user's query, descriptor terms, ISSN, or ISBN. The Discovery Links will be located on each record of the results set.


Sorting

The sorting features give you the opportunity to order your results based on the publication date or relevancy.

- **Most Recent First** displays the records in order beginning with the most recent.
- **Relevance Rank** displays records in order based on relevancy. Relevancy is determined through a rating system that weighs the records based on the number of times the term(s) appear in the record and where they appear.



The 'de-dupe' feature automatically removes any duplicate records that appear in your set of results. This feature is especially useful when you are cross-database searching. You can also use the 'Show Duplicates' feature to display the duplicates.

Printing, saving, and e-mailing records can be done by using the ‘Save, Print, E-mail’ function. This function also includes an exporting feature to a number of bibliographic managers such as [RefWorks](#) and the use of our output format editor, QuikBib.

Value-Added Features

CSA Illumina offers a number of value-added features to help with the search process and maximize the relevancy of search results.

Indexes

A browsable index is an alphabetical listing of terms used in a specific field of a database. You can browse this list to see, for example, how an author's name is spelled and, therefore, how they are indexed in the database. Searches may also be initiated in the browsable indexes.

The following Browsable Indexes are available in the *FRANCIS* database:

- Author
- Journal Name
- Language
- Publication Type
- Descriptors
- Classification

Take care with accents: you cannot include an initial accent in a search for a word, but second and following accented letters can be searched eg type “ecole” without the accent to find “école”; you can search “débat” or “création” to retrieve these words

Alerting Service for CSA Illumina

An “Alert” can be set up from the Results page, following the link “Alert me”. You will have access to “My Research” (also available in the top right corner, following the link “Please log in to My Research”).

If you are a new user, you must register first.

Creating an account will take 3 steps:

- 1 - Set your username and password
- 2 - Tell us more about yourself (country, status and your role at your institution) If you have an existing profile with CSA Illumina, *enter the e-mail address associated with that profile*, and we will transfer any information we have to your new My Research account. Selecting your area of interests will help to refine your results and provide more relevant material. If you have RefWorks, fill in your username and password
- 3 – Review your profile, and click Save & Continue.

Now you have set up your account, continue setting up your alert, by adding comment if you wish, setting the expiration date for your alert, choosing how you would like to receive this alert. If you would just like to save your search to use at another time, select “no delivery”. Click on Go.

Your newly saved alert is displayed at the top of your list of saved searches and alerts. You may click on the edit link to make changes to your alert such as changing the delivery method or expiration date.

You know how to create an alert from a search you had already performed in CSA Illumina. But if you want to set up alert without running a search first, you can easily do this by clicking on the “Create alert” link.

From this page, enter your search terms and select your database group.

In addition to create alerts and setting a custom group of databases, My Research allows you to set personal preferences for CSA Illumina (on the “interface options” link). Make your selection and Submit changes.

After you save your selection, you will need to open a new session of CSA Illumina to see them in action. Click on the “Login links” to see two custom Login links available on this page.

How to begin the electronic research process

A. Determine your goals:

1. State your research question:

What are the current trends concerning integration, with the development of European Union?

2. Set parameters for your search (ie, Type of Trends, development level, geographical location)

"What type of integration is going to be analyzed (economic, political, social, cultural, etc)?"

"Are we interested in a specific nation or group?"

"Do we consider the development as expansion, demography, integration, etc?"

"Which geographic locations are you interested in? (ie, all Europe, Eastern Europe, Western Europe, Central?)"

B. Identify general concepts:

1. Which general terms relate to your search?

“integration” “expansion” “European union”

C. Choose the appropriate database

1. Are there specific journals that specialize in Europe integration?

Build your search strategy:

A. Quick search:

1. Enter phrase or multiple search terms separated by Boolean operators AND to link terms, OR to link similar words or synonyms:

(integrat*) and (enlargement) and (union européenne or (european union)) in Quick Search box

Note:

Use French and English terms when you want to search on the Abstract or the Title, to retrieve more results.

Use French or English for the Descriptors, displayed in both languages

B. Advanced Search:

The drop boxes allow you to limit the search by any of the searchable field codes including Keyword (KW), Author (AU), Journal Name (JN), Descriptor (DE), Abstract (AB), or Title (TI). You can also limit your search to specific publication years and choose the record format. The descriptor field (DE) and abstract field (AB) will allow you to narrow down your search even more by locating specific descriptors and key words in the abstract.

DE=(integrat*) and KW=(élargissement or enlargement) and KW=(union européenne or (european union))

Note:

Consult the Descriptor Index for proper use of terms.

Analyzing Results

A. Good results:

If results are satisfactory, then download them to a bibliographic manager like RefWorks; alternatively, save, print, email your citations, or output them via CSA's QuikBib.

B. If results are not on target:

1. Check spelling of search terms and use browsable indexes to drop unnecessary or misleading terms.
2. Increase precision by searching specific fields such as the title rather than keywords, or by using the Descriptor Index

C. Too few/too many results:

1. Increase retrieval by using fewer ANDs and more ORs and more truncation

Example: KW=(enlargement OR élargissement OR expansion OR extension or growth) and KW=(union européenne or (european union) or EU)

2. Increase precision by using additional ANDs and fewer ORs (NOT can be used to exclude some terms)

Example: KW=(gypsy or itinerant) NOT (vagabond)

3. Ask a librarian to help you. Be sure to bring the result of this section along for them to review and develop.
